Exhibit tables are \$850 and include:

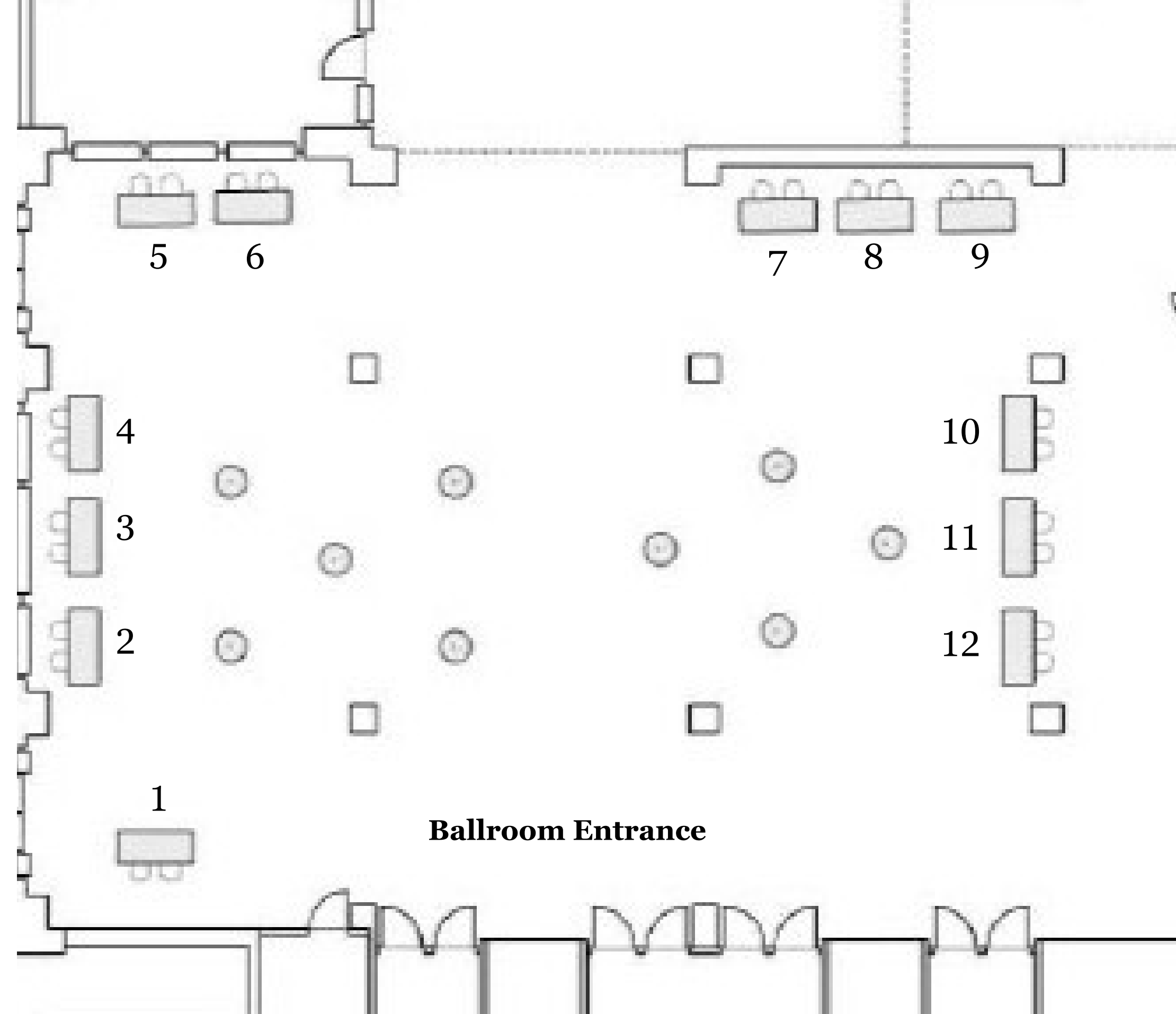
