What is Strategic Litigation?

- Large scale/long-term impact
- Part of an advocacy strategy
- Can be affirmative or defensive



How Can Strategic Litigation Be Used to Advance Health Equity?

- Can be used for various purposes:
 - To hold entities, including government, accountable
 - To defend "civil society and policies"
 - To define or clarify interpretation and implementation of laws
- Can protect or expand upon rights (or overturn or limit rights) in ways that affect health and equity
- Can impact government powers or authority in ways that affect health and equity



Advantages and Disadvantages



Advantages

- Can ensure implementation and enforcement of laws
- Can spur broader behavioral change
- Can hold the powerful accountable
- Can provide monetary compensation to harmed parties
- Can lead to legislative or regulatory change



Disadvantages

- Usually requires (sometimes significant) monetary resources
- Can be time intensive and require a long timeline
- May affect only one dispute
- Can create legislative or regulatory backlash
- Can be uncertain or unpredictable
- Can result in bad or harmful legal precedent

When to Consider Other Approaches



A totally new law is needed



Possibility of change through executive action



High risk of bad precedent or backlash



California Sugary Drink Tax Preemption

Timeline





Preemption Bill AB 1838

 In 2018, the beverage industry qualified a ballot measure threatening local government's revenue-raising ability

The measure could have devastating consequences

 Industry agreed to remove ballot measure days before deadline in exchange for preempting local sugary drink taxes until 2031

Preemption Bill AB 1838

 Meanwhile, several California cities had been preparing to enact sugary drink taxes

 Stockton youth activists traveled to Sacramento to implore legislators not to vote in favor of preemption

 State legislators voted for preemption, citing they had no choice



AB 1838 Elements

Preempted all new sugary drink taxes until 2031

Existing taxes could remain in effect but not change

Included a penalty provision

 If a charter city enacted a tax and a court found that tax to be a valid exercise of the charter city's constitutional authority, the state could not administer the charter city's sales tax















Getting a Second Opinion

 Sought expert review from municipal law and taxation specialist to confirm findings

Convening Partners and the Advocacy Community

- ChangeLab gathered partners and advocates from across the public health and social justice movements
- Collected perspectives and concerns from these stakeholders

Finding the Right Lawyer

 Before embarking on a lengthy litigation process, ChangeLab Solutions found a lawyer who was an expert and a good partner













Working with Plaintiffs

- ChangeLab prioritized plaintiffs most affected
- Two plaintiffs emerged:



- Martine Watkins, a resident and city council member of Santa Cruz, and
- 2. Cultiva La Salud, an organization dedicated to advancing health equity in the San Joaquin Valley












Finding the Money

Needed to ensure the lawsuit was viable from the financial perspective



Lawsuit Victory

March 2023

Santa Cruz Passes a Tax

November 2024

- Industry outspent tax proponents 50 to 1
- Tax was enacted by voters
- Industry filed a lawsuit claiming the tax is preempted
- Litigation is pending
- Santa Cruz victory would clear the way for other charter cities in California

Regulations v. Statutes

Regulations/Rules

- Drafted by administrative agencies
- Fills in the details
- Codified in an administrative code



Statutes/Ordinances

- Drafted by a legislative body
- Sets the big picture
- Codified in a statutory code or code of ordinances



Both have the effect of law.

What Are the Most Common Areas of Regulation for LHDs?



- 1. Food service establishments (75%)
- 2. Schools/day care (70%)
- 3. Septic systems (62%)
- 4. Recreational water (59%)
- 5. Body art (54%)

- 6. Hotels/motels (50%)
- 7. Lead inspection (50%)
- 8. Private drinking water (49%)
- 9. Children's camps (47%)
- 10. Campgrounds & RVs (43%)

Food Safety

- State and local health departments are the first line of defense
- They keep us safe against foodborne illnesses by:
 - Adopting food safety regulations,
 - Monitoring compliance, and
 - Responding to outbreaks





Why is Admin Law Important for Public Health Practitioners?

- Administrative law doctrines act as guardrails that shape how health departments and other agencies carry out their day-to-day work
- Guardrails can promote basic fairness for people and businesses, as well as agency transparency and accountability to the public
- This is particularly important for public health actions, where the fundamental principle is to balance the rights of affected individuals with protection of the common good


Why is Rulemaking Important for Public Health Practitioners?

- Public health regulations and other administrative actions profoundly impact the nation's health
- Understanding administrative law helps health departments influence or participate in the rulemaking processes of other agencies



Steps for Rulemaking

- 1. Conduct extensive research
- 2. Draft text of regulation
- 3. Provide public notice
- 4. Provide an opportunity for public comment
- 5. Revise and finalize the regulation



What is Health Equity?

"Health equity means that everyone has a fair and just opportunity to be as healthy as possible. This requires removing obstacles to health such as poverty, discrimination, and their consequences..."

Why Equitable Rulemaking?

- Increases accountability and builds support for regulations
- Increases civic engagement which improves public health
- Promotes fairness which is especially important for public health actions, where the fundamental principle is balancing individual rights with the common good





Equitable Implementation (EI)

- EI = Equity + Policy Implementation
- Policy Implementation:
 - Actions taken to carry out an enacted policy in a manner that best achieves its intended outcomes
 - Implementation activities include:
 - Education
 - Administration

- Monitoring
- Enforcement




Equitable Enforcement



The process of ensuring compliance with law and policy that considers + minimizes harms to underserved communities

Overenforcement

When enforcement of laws or policies produces disproportionate harms, particularly for marginalized communities



Underenforcement

When enforcement of laws or policies affords inconsistent or inadequate protections, particularly for marginalized communities


Having a centered perspective - thinking about all the stakeholders.

Along the continuum – regulatory in nature and subregulatory. We're talking about across / throughout the full constellation of things that influence how a law is implemented. Not all laws have regs that go along with it.

At each of those places, there are individuals/entities slotting in beyond formal rulemaking / other processes. (e.g., people in the permitting offices - what criteria are they using that go beyond regs)

What is Administrative Law?

- Governs the organization and activities of administrative agencies, including public health agencies
- Acts as "guardrails" for regulatory activities to promote basic fairness to people and businesses, as well as agency transparency and accountability to the public

Regulations vs. Statutes

- Regulations/rules are laws developed and finalized by administrative agencies (e.g., FDA, EPA, state and local health departments).
- Statutes/ordinances are laws developed and finalized by a legislative body (e.g., Congress, a state legislature, a city council, a county board of supervisors).


