


American Families for Vaccines (formerly known as SAFE) is the nation's first provaccine political advocacy organization.

### **PRO-VACCINE MOVEMENT:**


- Better coordinated

- Passing positive legislation seems more likely now








# Trends in Immunization Legislation







# **Immunization Rate Trends**


LOUISIANA ILLUMINATOR

- Amending State Civil Rights Code to create and protect the "unvaccinated class."
- Preventing employers from "discriminating" against employees based on vaccination status.
  - Hiring, firing, workload transfer, vulnerable patient population exposure, etc.
- Preventing employers from requiring employees to receive any, or mRNA-specific, vaccines.
- Individuals and/or businesses may not refuse to provide services based on an individual's vaccination status.
- Discrimination in a school setting, changing seating arrangements or classes.
- Discriminating against the unvaccinated in public places.



# **Food Sources**

- Any food that has received a vaccine must be labeled and regulated as a drug, aka "lettuce bills."
- Misdemeanor to grow food that contains mRNA.
- Labeling "contains vaccine material."
- Animals get vaccines...





### Vaccines Protect Animal and Human Health.

Like humans, animals receive vaccines to prevent disease and ensure their well-being. The U.S.

Department of Agriculture's Center for Veterinary Biologics (CVB) regulates all animal vaccines to guarantee safety, effectiveness, and quality.

For over 100 years, farmers have vaccinated livestock to protect animals and maintain a safe food supply.

### Oppose HB 113.

Maine House Bill 113 requires food labels to disclose the use of messenger ribonucleic acid (mRNA) vaccine material in food production.

# mRNA Vaccines

- Meat from animals that have not received an mRNA vaccine can be labeled "mRNA free."
- Preventing State Veterinarian from administering mRNA vaccines in an emergency situation.
- Banning mRNA products, with criminal penalties labeling "WMD".
- Pfizer-BioNTech COVID-19 vaccine in South Carolina, requiring verbal and written notice that the vaccine is new, that it contains fragments of bacterial plasmid DNA encapsulated in a lipid nanoparticle delivery vehicle, and that the long-term safety of the vaccine is unknown.
- Preventing any Emergency Use Authorization (EUA) vaccine requirements.
- Prevents state health agencies from advertising for EUA vaccines.



# **Vaccinated Blood**

- Blood donor must report their vaccination status.
- Blood donation recipients could request non-vaccinated blood.
- Requiring certain tests
   (which may not exist)
   for donated blood.

**Protecting Our Nation's Blood Supply** 



### Blood Donations are a Lifeline.

Blood donations are essential for maintaining a sufficient blood supply to meet the needs of patients requiring transfusions for various medical conditions. These include emergencies, surgeries, chronic illnesses, and treatments for diseases like cancer.

According to the American Red Cross, every two seconds, someone in the U.S. needs blood. Patients such as cancer patients, car accident victims, and individuals with sickle cell disease rely on multiple units of blood to survive and recover.

### The Impact of Limiting Blood Donations

Over 81% of the U.S. population has received at least one dose of a COVID-19 vaccine. Restricting blood donations from vaccinated individuals could result in a significant portion of the population being disqualified from donating blood, exacerbating blood shortages. Blood shortages put countless lives at risk, particularly for patients who require regular transfusions.

Bills that seek to limit blood donations based on vaccination status are both unnecessary and harmful. The components

# Education

### K-12 schools

- Reinstating or expanding religious and personal belief exemptions for public, private, charter, and homeschooled students.
- Removing any requirement to get vaccinated or show vaccination records to schools.
- Notifying parents about non-medical exemptions and how to obtain them.

### **Childcare Centers**

• Vaccine requirements are falsely being identified as a barrier to recruiting childcare providers.

### **Higher Education and Professional Schools**

• Medical, veterinary, pharmacy, nursing, national guard.





### Schools Keep Communities Safe.

Schools are pillars of our communities, providing safe, supportive environments for children to learn and grow. Public schools, along with the Board of Education and Department of Health, play a vital role in ensuring children have a healthy environment in which to thrive.

# Vaccine Recipient Bill of Rights

Imposing impossible standards for vaccine administration

- Demanding saline placebos in clinical trials
- Exemption from the VICP program
- Requiring definitive proof it stops disease transmission
- Prohibiting advertisements of vaccines except in limited circumstances, including within a private practice office to patient.
- Requiring specific testing or labeling for allergenicity, carcinogenicity, fertility.

Effectively blocks vaccine requirements, puts access at risk, and creates distrust.

# Inciting Fear about Vaccine Research

- "No person may develop, release, or take part in causing the release of any self-spreading virus or bacteria without the express written consent of each individual" that could be infected. Criminal offense.
  - Only research into zoonotic diseases that spread in wildlife
  - mRNA vaccines do not "shed."
  - Millions of dollars of cancelled funding for mRNA research
- Prohibiting "human gene therapy products" unless the manufacturer explicitly waives immunity from lawsuits related to product design defects.
  - mRNA vaccines are not gene therapy; they do not enter the nucleus or alter DNA.
  - Gene therapy is a completely different FDA-regulated category used for rare genetic disorders.

# New Legal Causes of Action

- An individual harmed by an employer-required vaccine may sue the employer.
- Personal liability for employers and providers who administer vaccines.
- State health liability for immunization promotion and any injury.
- Strict liability for vaccine mandates.



# **Parental Rights**

- Preventing or administratively burdening foster parents and group homes from vaccinating.
- Preventing vaccination requirements for foster families and adoption parents.
- Preventing teenagers from electing to vaccinate.
- Parent presence in school clinics.
- Opt-in data collection, impacting registries.


# Informed Consent

- Certain documents required in advance
  - Vaccine inserts
  - Excipient list
  - Risk of death warning
- Waiting period

# **Healthcare Discrimination**

- Preventing providers from refusing to accept, or dismissing, unvaccinated patients.
- Preventing providers from refusing to perform certain procedures, such as organ donation or transplant.

# **Establishing State VAERS**

- Patients can report alleged injuries.
- Physicians must report alleged injuries
- Medical examiners must report vaccination details.
- All publicly available.

# **Ingredient Prohibition**

Prohibits administration of vaccines containing mercury or aluminum.



# Free Range Medical Exemptions

- Any "medical" practitioner can issue a medical exemption based on their personal opinion that it may be detrimental to an individual's health.
- Removing any standardization or regulation regarding "medical conditions."




# **Constitional Amendments for Medical Freedom**

- "No law may require or coerce a person to receive or use a medical product, or impose a penalty, or deprive a benefit for refusing, or refusing to disclose, whether a person has received a medical product."
- Establishes an individual's fundamental right to medical freedom.
- Q: Is any vaccine request presumptively invalid—or only those without an exemption process?



# **Natural Immunity**

Legal recognition of "natural immunity" as equivalent to vaccination, requiring those who recovered from disease to be considered "fully vaccinated" and granting them the same status as vaccinated individuals.



# 2025 Vaccine Policy Forecast

- Message bills meant to erode confidence
- Interim hearings amplifying misinformation and MAHA agenda
- Copycat bills echoing RFK's talking points
- Possible pivot from mRNA to the broader childhood schedule
- Pet vaccine rules
- Ongoing need to educate lawmakers on basic science
- Use rulemaking to protect access



# Vaccine Legislation in Red States

Often rooted in misinformation and ICAN's model bills, the same legislators repeatedly sponsor anti-vaccine proposals with coordinated support from activists. Hearings are contentious, with opponents bringing families to testify—sometimes leaving our Families for Vaccines chapters as the only pro-vaccine voices in the room.

# Chris-Spotlight on West Virginia

- West Virginia has never allowed religious exemptions to school immunization requirements.
- In January 2025, the Governor issued an executive order directing public schools to accept them.
- A legislative attempt to codify this change (SB 460) failed, but litigation is now underway: a parent is suing the WV Board of Education for following the state code rather than the executive order.
- An immunocompromised student has intervened in the case.



Vaccine Legislation in Blue States

- In conservative states, advocates focus on defeating harmful legislation.
- In progressive states, there is an opportunity to advance proactive vaccine policy.
- California, Connecticut, Maine, and New York have eliminated non-medical school immunization exemptions; MA Families for Vaccines is working toward the same goal.
- States can coordinate to create a centralized framework for vaccine guidance—one that considers ACIP recommendations but does not rely on them exclusively.





# Spotlight on Massachusetts

- Bills S.1557 and H.2554 would remove the religious exemption to school vaccine requirements, leaving only medical exemptions.
- Legal context: Massachusetts has a long history of upholding vaccine mandates as constitutional.
- Rationale: Lawmakers point to exemption clustering, health risks, and the right to education.
- Status: Bills are in committee; strong opposition is mobilized and litigation is likely if passed.



# Final Thoughts

While anti-vaccine legislation and chaos at the federal level are deadly serious, it's important to keep perspective:

- Every state still has a pro-vaccine majority.
- Public sentiment remains the most powerful driver of policy.
- Pro-vaccine organizations are active at the local, state, and national levels—defending existing laws, advancing proactive protections, and building a broad pro-science movement.
- Pro-vaccine voices are more critical than ever, and there is renewed urgency across the country to safeguard access to vaccines.


