

THE PROMISE OF REPARATIONS: FINALLY ADDRESSING THE COMMUNITY CONDITIONS AND GENERATIONAL INJUSTICES THAT CREATE HEALTH DISPARITIES.

Grounding

- Reparations is a process of repairing, healing and restoring a people injured because of their group identity and in violation of their fundamental human rights by governments, corporations, institutions, and families.
- Those groups that have been injured have the right to obtain from the government, corporation, institution or family responsible for the injuries that which they need to repair and heal themselves.




Impact of Generational Wealth Stripping

- Estimated Debts Owed From Enslavement: Calculations for unpaid wages owed to enslaved people amounts to \$19.4 trillion in today's dollars.
- Estimated Debts Owed From Special Field Order No. 15: If each freedman was eligible to receive 40 acres of land, \$1.6 billion would have been paid in 1865, compounding to \$12.6 trillion at a six percent interest rate in 2019.
- Estimated Wealth Gap in California: According to a recent UCLA Study, the average household income in CA is \$92,100 for whites, \$105,000 for Asians and \$64,000 for Latinos while only \$56,800 for Black Californians.

A Government That Is \ Just: Repair In Motion

- California (2020): AB 3121 establishes the California State Reparations Task Force to develop recommendations for African Americans.
- Across the Nation (2020): Over 200 jurisdictions declare racism a public health crisis.
- Federal Policy (2021): House Resolution 40 is introduced to create a commission to study and develop reparation proposals for African Americans Act.
- **Evanston, IL (2021):** Evanston, IL passes and implements the first reparations initiative to address housing discrimination.
- (2021-present): From San Francisco to New York, a groundswell of local government commitments are made across the nation, including recent restitution in Palm Springs California to survivors of Section 14 burning and displacement. Over 225 reparations efforts are underway in local governments, school districts, and state entities.
